

* Different procedures may be applied according to the juvenile hearing system or the Juvenile Act, to an offender under the age of 20.

Request to victims

For your own safety and to prevent other people from suffering from the same sort of criminal incidents as you have, we sometimes need to ask victims several requests for investigative purposes. Your cooperation to the following procedures would be much appreciated.

Interview and questioning

When a victim reports a criminal incident to the police, the investigator in charge will question the victim about the details of the incident as well as the details of the offender. The victim is also requested at times to go through an interview by a public prosecutor, which is an important procedure for the prosecutor to determine whether or not to indict the offender.

Voluntary presentation of evidence

Victims are sometimes requested to submit personal belongings like clothes or any carry-on items that the victim had at the time of the incident. Those items will be used in trials as convincing evidence, although this procedure is optional and up to the victim. Those impounded items are usually returned to the victim after the investigation is terminated.

Presence at the investigation on the spot

Victims are sometimes requested to be present at the scene of the criminal incident. Although this procedure may take up some time, this is an essential procedure for the police to investigate the overall circumstances of the scene of the crime.

Victims assistance and relief system

Law assistance organization

This is a corporate organization to function as a central core of comprehensive law assistance to realize a community where citizens benefit from necessary information and law assistance to settle legal disputes. This organization provides information regarding victim assistance and civil case law assistance including free consultation service for those who have financial problem.

Civil case compensation claim system

A Criminal offense fulfills an illegal civil conduct and it is in contravention of the Article 709 and the following articles of the Civil Code, and a victim is entitled to apply and demand the offender and other persons concerned to indemnify the victim. This compensation system will be conducted according to the civil procedures based on the Civil Procedure Code, and the police is not authorized to be involved directly in the above system.

Lawsuit assistance system against organized crimes

A victim who wishes to apply for a civil lawsuit to demand indemnity for the damage caused by a member (members) of organized crime groups is, in some specific cases, entitled to apply for a loan for the lawsuit and receive other assistance provided by Ibaraki-ken Bouryoku Tsuihou Suishin Center (Ibaraki Anti-Violence Promotion Center).
